# Minutes of the Annual Parish Council Meeting held on Tuesday 23 May 2024 at 7.00 pm in the Dining Room at the Coach & Horses, Fenny Bentley

#### 1. Election of Chair

Cllr Miller was unanimously re-elected as Chair.

## 3. Welcome and apologies for absence

Cllr Miller welcomed everyone to the meeting. Apologies were received from Cllr S Spencer (DCC) and Cllr N Edwards-Walker (DDDC).

#### 5. Invited comments from County & District Councillors and members of the public

The resident commented that the village was looking untidy and unloved with weeds and potholes. It was noted that some pavements at Bentley Corner have been swept, although the pavement opposite Valley View was very narrow and dangerous for pedestrians.
